**The Remake of the Surveying & Spatial  
Information Regulation 2006**

The remake of the Regulation is directed by "Section 10 Staged repeal of statutory rules" of the *Subordinate Legislation Act 1989* which states;

- (2) *Unless it sooner ceases to be in force, a statutory rule published on or after 1 September 1990 is repealed:*
- (a) *on the fifth anniversary of the date on which it was published (in the case of a statutory rule published on 1 September in any year), or*
  - (b) *on 1 September following the fifth anniversary of the date on which it was published.*

Les Gardner, Manager Cadastral Management, Land & Property Management Authority will cover in his presentation: definitions; general principles of survey; datum line; bench marks; heights and strata; surveys for affecting interests; re-survey of property boundaries; accuracy of length measurements; checking accuracy of measurements; misclose tolerance; marking of rural surveys; roads to be marked with reference marks; procedure if monuments of original survey missing; surveyor to note nature and position of survey marks; new permanent survey marks; MHW & land adjoining Crown reserve; plan to indicate street address and type of survey; method of showing boundaries generally; and, reports doubts, discrepancies and difficulties.

There have been some controversial suggestions made, particularly in regard to strata surveys and including the street address on all DP Lots. All members are encouraged to attend.

As part of Les' presentation a 'comments and issues' questionnaire will be handed to members for completion; the results of which will be taken into account in the remake of the Regulation.

The new regulation is due to be in place by the 1<sup>st</sup> September 2011.

Also on the night will be the usual updates on the Institution, SMIC, BOSSI, Seniors Group and the Young Surveyors Group.
